Instructions

Instructions for Candidates:

- Fill out the Candidate Declaration form in full
- Complete the Nomination form
- File the completed forms with the KIA Returning Officer before the 3PM deadline May 14, 2018
- You will be notified if your Declaration is accepted or rejected

Eligibility

Eligibility rules for community directors are as follows:

- Fluent in Inuktitut;
- At least 19 years of age on Election Day;
- Member under the Nunavut Agreement;
- Physically and actually resident in the Kivalliq region for at least 12 consecutive months immediately preceding Election Day;
- Not a member of any Federal, Territorial or Municipal government or holds the office of Mayor;
- Has not been removed for cause from any office or employment with KIA or any other Regional Inuit Association or Nunavut Tunngavik Inc. within the three years immediately before Election Day;
- Does not have a relationship with any contractor, subcontractor, lessee, licensee or permittee which does business with KIA whereby the candidate or the business for which the candidate works earns any form of remuneration; and
- Is not a member of any of the Nunavut Planning Commission, the Nunavut Impact Review Board, the Nunavut Wildlife Management Board, the Surface Rights Tribunal or the Nunavut Water Board
- No person shall be a candidate for more than one position on the Board of Directors
- A Director of KIA who wishes to stand for election in mid-term of his/her current term of office shall resign his/her position before nominations are closed
