## **Nunavut Wildlife Management Board Call for Nominations (4 year term)**

The Nunavut Wildlife Management board is a co-management agency, working in partnership with Inuit and Government to manage Nunavut wildlife. Within the co-management system, the NWMB is the main body to make wildlife management decisions affecting both Inuit and non-Inuit in the Nunavut Settlement Area; members are required to act independently and impartially in making their decisions.

Interested candidates must carefully consider:

- Any conflict of interest between the individual's private interests and his or her public duties as an NWMB member;
- Familiarity with Nunavut wildlife issues, including relevant Inuit Qaujimagatuqangit and/or scientific knowledge;
- The individual's willingness to work cooperatively with fellow NWMB members, as well as various Inuit and Government organizations, in the management of Nunavut wildlife;
- The individual's willingness to consider and decide issues from a Nunavut-wide perspective;
- The individual's willingness to review briefing notes and related documents addressing numerous wildlife issues;
- The individual's willingness to prepare for and attend approximately four in-person NWMB meetings and eight NWMB teleconference meetings per year, during a four-year term;
- The individual's willingness to regularly participate in the conduct of NWMB public hearings, and to occasionally attend workshops concerning particular Nunavut wildlife issues; and
- Any related experience the individual may have as a board or tribunal member, especially within Nunavut.
- The individual must be an Inuit Beneficiary
